The 13th International Conference "TRIZfest-2017" will be held in Krakow, Poland, on September 14-16, 2017. It is organized by the International TRIZ Association (MATRIZ) in partnership with NOVISMO and several Polish business and Government organizations. The conference focus will be on networking. We invite every TRIZ practitioner, researcher, or a beginner to attend and to share your TRIZ related ideas with the world TRIZ community.

We are very fortunate to receive the support from the leading innovation organization in Poland, as well as Polish Governmental and business entities.

The Organizing Committee is now being formed. The currently appointed members are:

On September 13th TRIZ*fest*-2017 participants will have an opportunity to attend one or two tutorials. The tutorials are listed below. The entire day's tutorial fee is \$80. In addition, there is a potential for two or four Master Classes by TRIZ Masters Simon Litvin and Alex Lyubomirskiy. For a Master Classes to take place we must have a minimum of 25 paid attendees. You may see the topics of the Master Classes once you are on the payment page of the TRIZ*fest*-2017 registration process.

This year we offer the following tutorials:

- 1. Zenia Guin "Teaching 21st Century Skills".
- 2. Valeriy Prushinskiy, Oleg Feygenson "Modern TRIZ Tools: Hybridization with elements of Advanced Function Approach".
- 3. Valeri Souchkov "TRIZ for Business Applications".
- 4. Sergei Ikovenko "TRIZ for Patent Strategies. Best practices of world leading corporations".
- 5. Mark Barkan "How to Succeed in 21st Century.

Five tutorials are listed in the order they will be offered. Mark Barkan's tutorial will take place if one of the preceding tutorials is not offered for some reason.

A TRIZ-Pedagogy Session takes place on the afternoon of September 14. There will be a key-note address by Zenia Guin, 5-6 paper presentations and a Round Table discussion on utilization of TRIZ in the educational process. We invite all teachers and other interested people to attend this session. The fee for attending this session only is \$50.

The participation fee schedule is as follows:

- Full participation fee − \$550
 Students fee (conference only) − \$200
 Students fee (full participation − \$450
- Accompanying person fee \$250 (social programs only)

Organizations with 10 or more participants receive a 10% discount of the Full Participation



The conference program includes speeches by key-note speakers, scientific and practical papers presentations, case studies, and a session of the TRIZ Master Certification Council, where the public defense of the thesis for certification as TRIZ Master takes place. We also plan a panel discussion on the "TRIZ in World Class Corporations". At the TRIZ fest-2016 this discussion received a very positive feedback.

The 12th MATRIZ Congress is planned as the closing activity of the TRIZ fest-2017.

This hotel is located about 100 meters from the Krakow Old Town.
